Wherein, after printing the lottery tickets, Authorized Representative of the organizing Government received the lottery tickets and delivered to the Distributor as appointed by the Government of Nagaland and further to Area Distributor and retailers thereof.

Various security features such as QR Code are incorporated in lottery tickets to avoid duping/ tampering and entire scheme details are printed on the backside of lottery tickets to remove any confusion therein. Specimen tickets of Dear Morning (MRP Rs. 6/-, time: 1:00 pm onwards), Dear (MRP Rs. 6/-, time 4:00 Pm onwards) and Dear Evening (MRP Rs. 6/-, time 8:00 Pm onwards) are hereby enclosed for your necessary action.




